  - June 30, 2023 Notice of available amounts
  - August 12, 2023 5-year plan due to Federal Govt.
  - December 27, 2023 Initial proposal due
- Challenge Process
  - National Telecommunications & Information Administration (NTIA) will provide a model to utilize
  - Challenges can be initiated once
    - Initial Proposal V1 is approved
    - o Initial Proposal V2 is submitted
  - Challenges can be provided by
    - Local government orgs
    - Nonprofit orgs
    - o Broadband service providers
  - Challenge Timeline
    - o Entire process must be completed within 90 days
    - Need to provide 2 weeks for challenge and rebuttal submissions
    - Final location classifications must be published at least 60 days before states can allocate grant funds
  - Grant Actions
    - Requirements:
      - 100/20 (FED), 100/100 (NE)
      - Maximum of 100ms latency
      - 25% match requirement
      - Except in definitional high-cost areas
      - Limit grants to \$5 million
    - Scoring:
      - Priority broadband projects are considered first

- Minimal BEAD program outlay (higher match= higher score)
- Affordability
- Fair Labor Practices
- Additional Criteria
- Scored on number of unserved locations (min 80%)
  - Underserved locations on % of unserved locations
- Outreach Efforts:
  - Required to engage with stakeholders through entire process
  - Engagement must demonstrate:
    - Full geographic coverage
    - Meaningful engagement and outreach to diverse stakeholder groups
    - Utilization of multiple awareness and participation mechanisms/methods
    - Process transparency
    - Outreach to and direct engagement of unserved and underserved communities

# Mick Syslo - NDOT Roadway Design Engineer

- o Increase capacity and accommodate traffic growth; 4-lane expressway
- o Offline alignment (western half rural standard- 60mph; eastern half urban- 65mph)
- 2006 Public Meeting presented 2 Alternatives
  - A second Public Meeting was held in 2008 with updated Alternatives with reduced impacts
- The project was delayed due to funding availability in 2011
- When the Build Nebraska Act passed, the project was revisited in 2013
  - An another Public Meeting was held in 2016 presenting an off-alignment alternatives with reduced impacts
- Currently final design, preparing project of PS&E turn in > Letting
- City relinquishment upon project completion
- Project Status: 75% of ROW negotiated (33 tracts) ETA this fall
- September 2023 letting = \$46 million (20% with city GI)
- Construction: Spring 2024 (2 seasons, Fall 2025)

- Sets a goal that 40% of investments benefit the communities by:
  - o Increased affordable transportation
  - o Improving connection to good paying jobs and health care
  - Improving quality of life
- Applies to specific Formula and Discretionary programs such as:
  - National Highway Freight Program Formula
  - Carbon Reduction Program Formula
  - PROTECT (Promoting Resilient Operations for Transformative, Efficient, and Cost-saving Transportation – Formula and Discretionary
  - Disadvantaged Business Enterprise Supportive Services Formula
  - o On-the-job Training Supportive Services Formula
- Justice40 Identified 6 Categories of Investment
  - Transportation
    - Communities that spend more and take longer to get where they need to go
  - Health
    - Communities with adverse outcomes, disabilities, and low access to health care services
  - Environmental
    - Communities experiencing disproportionately high levels of pollutants and toxins
  - Economic
    - Communities with high levels of poverty and low access to jobs and education
  - Resilience
    - Communities vulnerable to hazards caused by natural disasters such as flooding and wildfires
  - Equity
    - Communities with a shared history of discrimination or other forms of disadvantage
- Potential Investment Areas:
  - Scottsbluff, North Platte, Kearney, Hastings, Grand Island, Norfolk, Columbus, Fremont, Lincoln, Beatrice
- Improving Discretionary Grant Applications
  - Make changes based on feedback from previous rejections
  - Identify projects that better align with Justice40 Initiatives that improve Nebraskan's accessibility, resilience, and equity
  - Expand Existing Diversity, Equity, and Inclusion (DEI) at NDOT
    - o Increase awareness and beneficial impacts
    - Modernize policies and business practices
    - Gather and analyze data to determine DEI impacts
- How Nebraskans Benefit from DEI and Civil Rights Compliance
  - Project Delivery:
    - Assess when and how to engage with minority, low-income, and Limited English Proficiency
    - Review ADA Accessibility and transition to compliance
      - Sidewalks (ADA curb ramps)

- Coordinate with and provide training for Federal-aid recipients
  - Transit and Local Public Agencies (Cities/Counties)

- Certify Minority and Women Owned Businesses as Disadvantaged Business Enterprise (DBE)
  - Increase competition
  - Grows small business
  - Allows Nebraska businesses to complete for Federal work in other states
- Increase small business and Disadvantaged Business (DBE) work in construction
  - Set Triennial and Project Specific Contract Goals
  - Conduct robust public involvement to set new FTA and FHWA Triennial DBE goals
- Grown DBEs
  - Up to 10 DBEs can be enrolled in the Business Development program
    - o Training and technical assistance
    - Customized business plans, including strategy for growth and sustained economic viability
- Increase Diversity and Growth opportunities within Construction Communities
  - On-the-job Training Program
    - Increase skills/knowledge base within the contractor's workforce
- Actively Monitor Prompt Payment from Prime Contractors to Subcontractors
  - Payment to subcontractors within 20 days after the prime contractor receives payment
- Continue exploring new opportunities for workforce development in the transportation industry
  - Identify and establish partnerships with agencies, schools, and others
- Carbon Reduction Program Update
  Ryan Huff NDOT Chief Strategy Officer
  - Carbon Reduction Program:
    - FHWA Carbon Reduction Program (CRP):
      - \$6.4 billion in formula funding for states and localities over five years
      - Geared towards reducing transportation greenhouse gas emissions from on-road highway sources
      - Important considerations and related priorities include safety, complete streets, equity, climate change, job creation, and program evaluation
        - o Requirements:
          - Be in the STIP/TIP
          - Meet all requirements imposed on Federal-aid highway projects (e.g., NEPA, etc.)

- Include matching funds (80/20)
- Nebraska Apportionments
  - Total Funding = ~\$9.2 M for FY2022\*
  - A 65% apportioned to specific areas ~\$6.0M
  - MPOs Lincoln/Omaha/GI/SSC ~\$3.2M
  - Population Centers 50K to 5K ~\$960K
  - Population Centers under 5K ~\$1.8M
  - 35% can go to any area ~\$3.2M
- Carbon Reduction Strategy (CRS) Requirement
  - Due by November 15, 2023 resubmit every four years
  - Must consult with state MPOs
  - Must identify projects and strategies to reduce transportation greenhouse gas emissions (i.e. carbon)
- NDOT CRS Project Overview
  - Foundational Research Internal Coordination External Outreach
    CRS Development
- Carbon Reduction in NDOT Plans and Initiatives
  - Nebraska State Transportation Improvement Program (STIP)
  - Nebraska Long Range Transportation Plan (LRTP)
  - Nebraska State Freight Plan
  - Nebraska Transportation Asset Management Plan (TAMP)
  - Transportation Systems Management and Operations (TSMO) Plan
  - Strategic Highway Safety Plan (SHSP)
- Reducing Carbon Emissions
  - Transportation System Strategies
    - Fuel Economy, Fuel Switching, VMT Reduction, Congestion Management (Operational/ITS)
  - Agency Activities
    - Agency fleet vehicles, Construction Materials and Methods, Streetlights and Traffic Control, Other Facilities and Energy Use
- Emerging NDOT Approach to CRP
  - NDOT will focus on 4 eligible project types that have widespread application, these include:
    - Use of sustainable construction materials (concrete and asphalt)
    - o Energy efficient street lighting and traffic control devices
    - Advanced transportation management, congestion management, and ITS
    - Traffic Monitoring, management and control facility or program
- Questions to work through:
  - Eligibility
  - Justice40
  - Other Clarifications will influence other CRP and CRS approaches and decisions
    - o EX: "Are roundabouts on eligible CRP project type?"

- · Willis Hunt, Hastings
  - Past District employee of NDOT and worked as a past City Engineer of Hastings. The Hastings Southeast project has his interest as it's a project within his community. The project has been around for awhile and the city council has recently approved the design of the project but there isn't a designated truck route. He's concerned about the truck traffic. US Highway 6 (US-6), half the traffic is semi traffic as it's a large agricultural community including many factories and a large retirement village located in the vicinity of this project. Getting the trucks off US-6 should be the priority of the State. The roundabouts seem to function well, one was recently added in Adams County. He recommends placing a roundabout at J Street/Elm Street intersection to assist with the growing truck traffic.
